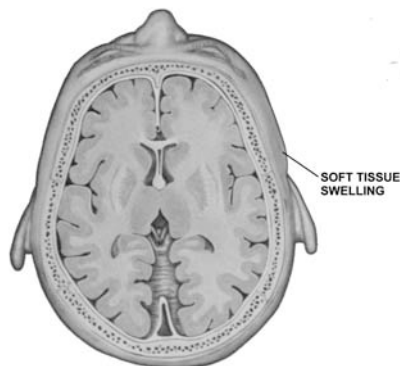

SETTLEMENT DISCUSSIONS

According to court records: Defendants each had a \$1,000,000 insurance policy with Williamsburg National Insurance. Plaintiff made Cal. Civ. Proc. Code § 998 offers to each defendant for payment of their limits. At the mandatory settlement conference plaintiff offered \$1,750,000. The defense collectively offered \$400,000 at the conference.

Gomez v. Los Angeles County Metropolitan Authority, Docket number: VC058743, Norwalk. Judge: Not reported. Trial type: Settlement. Settlement date: 9/5/2012.

SETTLEMENT: \$1,200,000

A few days before trial, the parties attended private mediation before Michael D. Moorehead where the case was settled for \$1.2 million.

FACTS/CONTENTIONS

According to plaintiff: Plaintiff Martin Guzman Gomez was struck by the right rear tire of a defendant Los Angeles County Metropolitan Transportation Authority Bus. Plaintiff alleged defendant bus driver violated numerous vehicle codes.

Defendants denied liability and contended plaintiff was negligently outside the marked crosswalk, intoxicated and was the sole cause of the accident.
